Kwik Kopy Central City Prize Draw Promotion – 6 Months of Prizes plus a chance to win a travel voucher to the value of \$10,000

Start Date: 1st October 2014

Purchases Close: 31st March 2015

Final Entries Close: 12th April 2015

Draw dates: See under “Timings” heading

Redraw date: See under “Timings” heading

Eligibility and Entry

1. Entry into this promotion is only open to businesses operating in NSW who are customers of Kwik Kopy Central City (**KKCC**) or Kwik Kopy Elizabeth Street (**KKES**) and whose authorised representative complete the entry requirements outlined below (“**entrants**”).
2. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
3. Entrants must be within the Promoter’s trading terms throughout the promotional period and must not have overdue monies owing as at the relevant draw date in order to be eligible to claim any prize. Any invoices relating to a winning entry must be paid in full before a prize can be collected.
4. To enter and be eligible to win, an authorised representative (aged 18 years or over) of an entrant must, on behalf of the entrant:
 - 4.1 spend \$250 or more in one (1) transaction on print, design and/or digital at KKCC or KKES and receive a valid invoice for their purchase between 01/10/2014 and close of business on 31/03/2015 (**Qualifying Transaction**); and
 - 4.2 visit www.kwikkopy.com.au/hawaii and follow the prompts to complete the entry form, including their full name, company details, invoice number and invoice amount of the Qualifying Transaction and valid email address and submit during the registrations open period for their month of purchase (as specified in clause 9).
5. Multiple entries are permitted, subject to the following: (a) one (1) entry will be awarded for each \$250 increment spent in a single Qualifying Transaction; and (b) each entry must be submitted in accordance with entry requirements. For example, if an entrant spends between \$250 and \$499.99 in a single Qualifying Transaction, they will be eligible to receive one (1) entry in respect of that Qualifying Transaction, if an entrant spends between \$500 and \$749.99 in a single Qualifying Transaction, they will be eligible to receive two (2) entries in respect of that Qualifying Transaction, etc.
6. Entrants will receive a confirmation email confirming their entry within 24

hours of entry submission.

7. Incomplete or indecipherable entries will be deemed invalid.
8. Entrants must retain a copy of their purchase invoice(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant's entries and forfeiture of any right to a prize. Purchase invoices(s) must clearly specify the store of purchase, amount spent and that the purchase was made during the relevant purchase period but prior to entry.

Timings

9. There will be a draw conducted for each month of the purchase period (each a "**Monthly Draw**"), for a total of six (6) monthly draws. Purchases and entries into each Monthly Draw open at 12.00am and close at close of business (for purchases) and at 11.59pm AEDST (for entries) on the dates specified in the table below. All Monthly Draws will take place at Kwik Kopy Central City, 70 Pitt Street, Sydney NSW 2000, on the dates in the table below at 9am AEDST. Entries in each Monthly Draw will NOT be entered into any subsequent Monthly Draws.

10. At the conclusion of the Monthly Draws, an additional draw will also be conducted from the winners of the Monthly Draws ("**Major Draw**"). Prizes

Monthly Draws

14. The first valid entry drawn in each Monthly Draw will each win one (1) \$249 "5th AVENUE Sunglasses voucher from SUNGLASS SPECTACULAR and one (1) \$150 restaurant voucher from SUBSOLO, Sydney. Total value of each Monthly Draw prize is \$399. Total prize pool value of all Monthly Draws is \$2,394.

15. Vouchers will be delivered to the winners or available for pick up from the place where the Qualifying Transaction was made. The Promoter, KKCC and KKES hold no responsibility for vouchers that aren't received due to the winner providing incorrect details or if they aren't claimed before the voucher expiry date. Prizes must be redeemed by the voucher expiry date or the prize will be forfeited.

Major Draw

16. The first valid entry drawn in the Major Draw will receive a travel voucher from the travel agent nominated by the Promoter, to the value of \$10,000, toward a holiday to Hawaii or any other destination selected by the winner, subject to availability and the voucher budget.
17. The prize must be redeemed within 12 months of the draw date otherwise the winner will forfeit their right to prize.
18. The winner will be required to deal directly with the travel agency specified by the Promoter so that they can select their preferred holiday destination and travel dates. The winner can elect to travel alone or to travel with a companion(s). The maximum value of the prize is up to \$10,000 (inc GST), regardless of the number of travellers. In the event that the winner's chosen holiday is valued at less than \$10,000 (inc GST), any remaining value of the voucher will be forfeited. The voucher can only be used toward a single holiday booking and must be redeemed in one (1) transaction.

Unless otherwise stated by the travel agent, the voucher cannot be used toward travel insurance, passports, visas, taxes not included in the price of a ticket, meals, ground transportation, additional flights, accommodation or any other costs of a personal nature that are not specified as inclusions of the holiday package chosen. Compliance with any health or other government requirements is the responsibility of the prize-winner and any companion.

General

20. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
21. The Promoter reserves the right, at any time, to verify the validity of entries, authorised representatives and entrants (including their details, age (if applicable) and place of residence/business) and reserves the right, in its sole discretion, to disqualify any individual or entrant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. 25. Any ancillary costs associated with redeeming any voucher are not included. Any unused balance of a voucher will not be awarded as cash. Redemption of each voucher is subject to any terms and conditions of the issuer including those specified on the voucher.
26. Subject to the unclaimed prize draw clause, if for any reason a winner does not take/redeem a prize (or an element of the prize) by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.

34. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize

claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner, authorised representative or entrant; or (f) use/redemption/taking of a prize.

35. As a condition of accepting a prize, each winner (and their companions, if applicable) must sign any legal documentation as and in the form required by the Promoter and/or prize suppliers in their absolute discretion, including but not limited to a legal release and indemnity form.

The Privacy Policy also contains information about how to opt out, access, update or correct PI, how to complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with.
