

**"POSTERS & SIGNAGE" PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Kwik Kopy Australia, (ABN 27 002 218 822) of Level 9, 50 Berry Street, North Sydney NSW 2060, telephone (02) 99675500.
3. Entry is only open to registered businesses operating in Australia (each an "**Eligible Business**").
4. The Eligible Business must be within the Promoter's trading terms throughout the promotional period and must not have overdue monies owing as at the draw date in order to be eligible to claim any prize.
5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
