

“KWIK KOPY WIN A BIKE” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoters are Kwik Kopy Central City Group (ABN 54 146 247 565) of 70 Pitt Street Sydney NSW 2000, telephone (02) 8226 9200 and Kwik Kopy Wynyard Group (ABN 60 606 071 924) of B1, 70 Pitt Street Sydney NSW 2000, telephone (02) 9262 4040.
3. Entry is only open to registered businesses operating in New South Wales (each an “**Eligible Business**”). Agencies associated with this promotion are ineligible to enter.
4. The Eligible Business must be within the Promoters’ trading terms throughout the promotional period and must not have overdue monies owing as at the draw date in order to be eligible to claim any prize.
5. Promotion starts on 01/10/2022 and ends at close of business on 31/12/2022 for purchases, with final entries closing at 11:59pm AEST on 7/01/2023 (“**Promotion Period**”).
6. The Promotional Period will be comprised of three (3) monthly draws (each a “**Monthly Draw**”).
7. To be eligible to enter a Monthly Draw, an Eligible Business must spend a minimum of \$250.00 (ex. GST) in a single transaction at a participating Kwik Kopy Centre during the Purchase Period for the relevant Monthly Draw, as outlined in the table in clause 9, (each a “**Qualifying Transaction**”). A full list of participating Kwik Kopy Centres can be found at the end of these Terms and Conditions.
8. To enter the relevant Monthly Draw, an authorised representative, on behalf of an Eligible Business, must then visit www.kwikkopy.com.au/bike follow the prompts to the competition entry page, input the requested details (including their full name, the name of their business, valid email address, contact phone number and the invoice number and amount associated with their Qualifying Transaction) and submit the fully completed online entry form during the Entry Period for that Monthly Draw, as outlined in the table in clause 9. One (1) entry will be awarded for each \$250 (ex. GST) spent in a single transaction. For example, if an Eligible Business spends between \$250 and \$499 in a single transaction, they will be eligible to receive one (1) entry for that transaction, and if an Eligible Business spends between \$500 and \$749 in a single transaction they will be eligible to receive two (2) entries in respect of that transaction.

10. The first valid entry drawn in each Monthly Draw will each win one Real Ryder Indoor Cycle valued at \$3200 (each a **“Monthly Draw Winner”**).
11. Eligible Businesses must retain their original purchase receipt/invoice for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoters, result in invalidation of ALL of an Eligible Business’s entries and forfeiture of any right to a prize. Purchase receipt/invoice must clearly specify the Kwik Kopy store of purchase, the amount spent and that the purchase was made during the relevant Purchase Period and prior to entry.

The Promoters reserve the right, at any time, to verify the validity of entries and Eligible Businesses and reserve the right, in their sole discretion, to disqualify any Eligible Business who the Promoters have reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoters’ discretion. Failure by the Promoters to enforce any of their rights at any stage does not constitute a waiver of those rights. The Promoters’ legal rights to recover damages or other compensation from such an offender are reserved.
13. If there is a dispute as to the identity of an Eligible Business, the Promoters reserve the right, in their sole discretion, to determine the identity of the Eligible Business.
14. The Promoters’ decisions are final and no correspondence will be entered into.

16. Subject to the unclaimed prize draw clause, if for any reason a winning Eligible Business does not redeem a prize by the time stipulated by the Promoters, then the prize will be forfeited.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoters (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
23. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoters (including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters) due to any reason beyond the reasonable control of the Promoters; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or Eligible Business; (f) use of the prize.
24. The Promoters collect personal information ("**PI**") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
